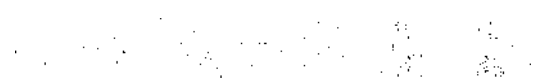

- Rampart has offered to cut his outstanding change order proposals in half in consideration of eliminating the balance of the punch list created by SSP. His outstanding proposals add to \$8,957.00 for work we directed him to perform including the excavation of the existing underground storage tank and the sewer line in the rear of the Meeting room. He is willing to take \$4,500.00 and for

another \$1,000.00 he will install a new roof over the southeast entrance of the building (including repairing the damaged ceiling.
